Pursuant to the Declaration of Covenants, Conditions, and Restrictions For The Traditions, recorded on March 3, 2004 at Volume 5901, Page 1, Official Records of Brazos County, Texas, as amended from time to time (the "Declaration"), the Board of Directors (the "Board") of the Property Owners Association has adopted this Fines Schedule.


After the failure of an Owner, in the judgment of the Board, to adequately cure any violation of the Declaration within 30 days after written notice of such violation has been provided to the Owner by the Board or any management company acting on behalf of the Property Owners Association ("Management Company"), the Board, acting on its own or through the Management Company on behalf of the Board, may levy and collect fines against such Owner as follows:

<u>Notice</u>	<u>Fine</u>
2 nd Notice	\$ 50.00
3 rd Notice	\$100.00
Each Additional Notice	\$150.00

Notices, and thus additional applicable fines, shall not be sent to an Owner any sooner than 30 days prior to the previous notice for the same violation.




